Grandfather Credit

The following are means to verify the grandfather credit status of someone eligible for such credit under Section 97.505 of FCC Rules. At VE test sessions it is the applicant (not the VEs or coordinating VEC) who is responsible for supplying the evidence of holding valid grandfather credit:

Valid Forms of Examination Element Credit

At a test session, the VEs will review all credit documents presented by applicants. FCC does not require the applicant to have been <u>continuously licensed</u>. Such valid credit documents may include:

* For 5 WPM (Element 1) Credit,

- A Novice license held at any time by the applicant. An original Novice license document or copy, or a Callbook listing showing class of N=Novice (or a listing showing a WN#xxx, KN#xxx or WV#xxx Novice only call sign) is acceptable.

- A Technician license issued before February 14, 1991. An original Technician license document or copy, or a 1991 or earlier Callbook listing showing class of T=Technician is acceptable.

- An original Technician license document or copy with the following statement printed on the license under *Special Conditions/Endorsements*, "License Class Converted Per 97.21a3".

- A "Technician Plus" license issued at any time is acceptable. An original "Technician Plus" or "Tech Plus" license document or copy, or any Callbook listing showing class of P=Technician Plus is acceptable.

* For any credit, a CSCE issued within the previous 365 days for Element Credit (credit as indicated) is acceptable.

* For 5 WPM (Element 1) and General written test (Element 3) credit, persons who took a 50-question Technician/General written test before March 21, 1987 receive grandfather Technician licensees credit. This can be verified if an applicant presents any of the following:

- Per FCC Rules, an FCC Technician license issued before March 21, 1987, as indicated on the license.

- An original Element 3 CSCE issued before March 21, 1987, is acceptable as proof.

- If licensed in the mid-'70s or after, FCC will issue a <u>License Verification Letter</u> (see items 5 and 6) indicating that the applicant was licensed as a Technician licensee prior to March 21, 1987. To request such a letter, write to FCC, ATTN: Amateur Section, 1270 Fairfield Rd, Gettysburg, PA 17325 (or fax 717-338-2696).

- For 1966 or more recent records, an FCC Records Contractor extract/certification from FCC Fiche Records can be obtained. There is a charge for this service. For assistance in acquiring copies of FCC documents, please contact "Best Copy & Printing, Inc" (BCPI) at: Telephone 202-488-5300; TTY 202-488-5562; Fax 202-488-5563; E-mail requests, help & orders: <u>fcc@bcpiweb.com</u> or via the web at <u>http://www.bcpiweb.com/new_services/fcc.html</u>

- A 1987 Edition, or earlier, Radio Amateur Callbook listing is acceptable as proof (be sure to include the year of publication reference, if not printed on the page) so long as the license class is shown in the listing (only Callbooks Fall 1967 or later show license class).

- QRZ.COM has posted a copy from their archives of their very first CD ROM product on their web page, as originally published in 1993. This data includes <u>licensees from 1983 to 1993</u>. A printout of such a listing from this CD ROM, showing a Technician license effective/begin date prior to 3/21/87 is acceptable.

In and of itself, any Conditional, General, Advanced or Extra class license carries no grandfather credit whatsoever, per FCC Rules. **DOWNLOADED FROM ARRL WEBSITE**

KB5AVY is Winner of Third Annual Lynch Award



(Dec 27, 2005 [REVISED Dec 28, 2005 14:02 ET]) — Dr Roberto Dabdoub, KB5AVY, of Metairie, Louisiana, has been named the recipient of the W. Sandy Lynch (W7BX/7J1ABV) Memorial Award. Given annually by the Tokyo International Amateur Radio Association (TIARA), the award seeks to exemplify Lynch's dedication to the hobby and his personality. For 20 years, Dr Dabdoub, a native of Honduras, has kept four repeaters on the air in the New Orleans area, and one of them remained working in the metro area following Hurricane Katrina. During a critical period, his system became the only link between the Baton Rouge emergency operations center and other relief and emergency centers involved in critical rescue work. The repeater was able to stay on the air because of the auxiliary power source at its location, Ochsner Clinic Foundation. "There were many ham radio

operators and stations, both on HF and VHF, involved in the response to the Katrina disaster," TIARA President Steven Herman, K7USJ/7J1AIL, said in announcing the award winner. "We want this year's award to symbolize what a single ham and our socalled old-fashioned communications systems can do for the public when disaster strikes." TIARA says Dr. Dabdoub lost his home in the disaster. Wearing Santa hats, the astronaut and the cosmonaut extend Christmas and New Year's greetings to everyone on Earth in a video clip available from NASA TV during which they take turns at the microphone. In it, McArthur says that this is his favorite time of year, and he regrets not being able to spend it with his family this year. "As we look down on the earth, especially during this time of year, it really strikes us how fortunate mankind is to live on such a wonderful, beautiful planet," McArthur goes on to say during the greeting, which runs about almost four

minutes. "And also we realize we have great responsibilities as stewards of this planet." McArthur and Tokarev will return to Earth in April.
