Minutes of the Ole' Virginia Hams Amateur Radio Club Meeting Jan. 19, 2004

The meeting was called to order by President Ruth Frock/KU4WH at 2001 Eastern time.

Following the Pledge of Allegiance, all present stated their names and callsigns. There were 24 members present.

PROGRAM

Wayne/AG4ZZ provided OVH a presentation on "The Joy of QRPing."

If you want build your own QRP rig, you need good vision, good lighting, good magnification and very tiny fingers. You can throw a QRP rig and a small battery in your backpack. Several vendors are coming out with QRP rigs. Power can be adjustable by the power supply. You need a real antenna that is pretuned to be effective. The better the antenna, the better your results, especially if you lower your power. Biggest threat is QRM and powerful signals booming in on top of you. Another problem is the conditions themselves (propogation). When you think about QRP, think about the power and think about the receiver. Sometimes it's better to wait for someone to call CQ and respond rather than to call CQ yourself.

The Dulles Drill is set for May 8th. The following has been sent to all ARES members, as well as OVH members:

On Saturday, May 8, 2004, the Metropolitan Washington Airports Authority (MWAA) will be having a disaster drill at the Dulles International Airport. This drill is a full dress rehearsal for a real event and will happen rain or shine. The Amateur community has again been invited to participate in this drill.

This is the first drill since the events of September 11, 2001 and as a result, security concerns are in place. Because of this, the names of Amateurs who wish to participate, must be submitted to MWAA in advance of the drill. The drill is open to all amateurs. If you wish to participate, please send me (**David/KG4GIY**) an email indicating that you wish to participate, and include your full name, current call sign and a contact number where you can be reached.

If you wish to participate, you might want to consider that most of the communications work is manning the transportation buses from the "crash site" to area hospitals. This means that you should possess or have access to a dual-band (2/440) mobile radio (capable of greater than 5 watts output), an antenna(s) with the ability to be mounted/secured to almost any surface (metallic, non-metallic, mirror mount), and a power source for a minimum of 3 hours of operation (assume 35% duty cycle at full output wattage). Because personal vehicles will not be permitted beyond the staging area, all gear must be "portable." Transportation will be provided from the staging area to the work areas. It is advisable to bring a dual-band (2/440) HT as well, also with a minimum of 3 hours of power as well. Some of the work may involve shadowing officials or providing communications for agencies that do not have their own.

There will also be a limited need for packet operators. If you have a portable packet station that meets the voice requirements, please let me know as well.

I would like to submit the list of volunteers to the **Loudoun County EC** by Tuesday, February 17, 2004 so that he can combine it with the lists from the other jurisdictions and submit it as a unified whole.

This promises to be an exciting and educational drill and I hope you will take advantage of the training opportunity.

We will also be supporting the Hospital during this exercise.

League Files "A Plan for the Next Decade" with FCC



(Jan 28, 2004) -- The ARRL has filed a *Petition for Rule Making* asking the FCC to amend its Part 97 rules to complete the Amateur Service restructuring the Commission began in 1999 but left unfinished. The League wants the FCC to create a new entry-level license, reduce the number of actual license classes to three and drop the Morse code testing requirement for all classes except for Amateur Extra (see "ARRL to Propose New Entry-Level License, Code-Free HF Access"). The ARRL says its petition follows in the footsteps of changes in Article 25 of the international *Radio Regulations* adopted at World Radiocommunication Conference 2003. Among those changes, WRC-03 deleted the Morse testing requirement for amateur applicants seeking HF privileges and left it up to individual countries to determine whether or not they want to mandate Morse testing. While several countries--including Germany, the UK and Australia--already have dropped their Morse testing requirements, the ARRL

emphasized in its petition that Morse code is not the primary issue at hand. **Downloaded from ARRL Website**

Broadband Over Power Line on FCC's February 12 Meeting Agenda



(Feb 6, 2004) -- The FCC will consider a *Notice of Proposed Rule Making (NPRM)* concerning changes to its Part 15 rules as they apply to so-called "access" Broadband over Power Line (BPL) systems when it meets February 12. Last April the Commission issued a *Notice of Inquiry (NOI)* in ET Docket 03-104 on the subject of BPL--a form of carrier current communication. The Commission's *NOI* sought input on the amendment of Part 15 regarding new requirements and measurement guidelines for access BPL, which uses exterior power lines to distribute broadband content and provide Internet access. Padalka, 45, will serve as Expedition 9 commander and *Soyuz* commander, while Fincke, 36, will be the NASA ISS science officer and flight engineer. They have been training together as a space station crew for nearly two years, NASA said. Their experience as a team was cited as a primary reason for the personnel shift. The

A bill in the Vermont House, H.602, not only would incorporate the essence of PRB-1's stance that local governments must "reasonably accommodate" Amateur Radio communication with "minimal practicable regulation," it would include a schedule of minimum regulatory heights for antenna structures. Sponsored by Rep Ira Trombley of Grand Isle, H.602 has been referred to the House Local Government Committee.

AO-40 Command Team Plays the Waiting Game



(Feb 3, 2004) -- Ground controllers for the now-dark AO-40 satellite are waiting for something to break aboard the spacecraft. Specifically, they want one of the cells of the main battery bank to open up and "unshort" the power bus. That open circuit then could mean the command team would be able use the auxiliary batteries--now tied in parallel with the main battery bank--to restart the satellite. The command team hypothesizes that a failure within the main battery is clamping the bus voltage low. The command team meanwhile continues to signal the satellite to turn off the main batteries and turn on the auxiliary batteries and the 2.4
