Bogus ARRL.net Messages Circulating Via E-Mail



(Mar 3, 2004) -- Several members have notified ARRL that they have received e-mail messages alleging to be from the <u>ARRL E-Mail Forwarding Service</u>, "The ARRL.net team" or some variation. The messages, which often carry a subject line along the lines of "Warning about your e-mail account," indicate that the recipient's ARRL E-Mail Forwarding Service <call sign>@arrl.net address will be closed within three days because of an alleged violation of acceptable practices. These messages are false and did not come from The ARRL Forwarding Service. They are the result of one of the variants on a number of viruses now permeating the Internet. A file usually is attached to these messages. As always, *do not open* any attachments that you cannot identify. Opening the file could result in your computer being infected by a virus. This is only one of the several virus-laden

messages currently propagating across the Internet. The ARRL advises its members to be cautious in opening any message and/or attachment, even if it appears to be from someone you know. All of these viruses use e-mail addresses from the address book of an infected computer to falsify the "From:" address in the header to make it appear that the message is from someone the recipient knows.

(Jan 19, 2004) -- The ARRL will ask the FCC to create a new entry-level Amateur Radio license that would include HF phone privileges without requiring a Morse code test.

FCC Proposes Rules for BPL Systems



(Feb 25, 2004) -- The FCC this week released its *Notice of Proposed Rule Making* (*NPRM*) on Broadband over Power Line (BPL) systems. The 38-page *NPRM*--in ET Dockets 03-104 and 04-37--proposes amendments to FCC Part 15 rules to define so-called "access BPL," make rules specific to BPL systems and provide measurement guidelines for BPL devices and systems. It would make no changes to Part 15 emission limits for unintentional radiators, however. ARRL CEO David Sumner, K1ZZ, says that while Part 15's current limits on unintentional radiators on HF may be appropriate for short-duration, narrowband emissions, they are inappropriate for the sort of long-

duration, broadband emissions BPL would employ. He compared short-duration, narrowband emissions at the Part 15 radiated emission limit to a helicopter flying overhead.

A glimmer of hope for AO-40



(Mar 10, 2004) -- A weak "noise" on the AO-40 2.4-GHz beacon frequency has raised hopes that AO-40 may still be alive. AO-40 has been silent since January 27 (UTC), in the wake of a precipitous voltage drop. The satellite's controllers believe that one or more shorted battery cells are at the root of the problem. Colin Hurst, VK5HI, of the AO-40 command team reports that on March 9 between 0310 and 0320 UTC (orbit 1541) he "noted a noise peak of 4 to 5 dB" in the vicinity of the expected beacon frequency after he'd issued a transmitter reset command

sequence to the satellite. "The width of this peak was about 5 kHz," he said. After listening for about 15 seconds, he issued a command to shut down the transmitter, and the noise peak disappeared. Hurst said he also transmitted several commands involving the auxiliary batteries but did not attempt to turn the beacon on again. "This tends to suggest that the IHU [Internal Housekeeping Unit computer] and L Band [1.2 GHz] receiver are operational," Hurst said. The AO-40 command team theorizes that a cell in the main battery pack has shorted, clamping the bus voltage below the point where it can operate the satellite. The spacecraft's auxiliary batteries are believed to be in parallel with the main batteries, and commands sent so to swap to the auxiliary batteries have been unsuccessful. AO-40 Earth stations are continuing to send commands to the satellite in order to switch the batteries. Updates on AO-40 are available on the AMSAT-DL Web site.

ARRL's Logbook of the World

ARRL's *Logbook of the World* (LoTW) system is a repository of log records submitted by users from around the world. When both participants in a QSO submit matching QSO records to LoTW, the result is a QSL that can be used for ARRL award credit.

To minimize the chance of fraudulent submissions to LoTW, all QSO records must be digitally signed using a digital certificate obtained from ARRL. Obtaining such a certificate requires verification of the licensee's identity either through mail verification (US) or inspection by ARRL of required documentation (non-US).

Software developed by ARRL can be used to convert a log file (in ADIF or Cabrillo file format) into a file of digitally signed QSO data, ready for submission to LoTW.

LoTW began operation on September 15, 2003.
