Harry Vorhauer/W4PVA in Hospital

Received several emails between 6/7/03 and 6/9/03 pertaining to Harry from **Jan/KE4TMW**, **Steve/N4OGR**, and **Art/KW4AW**. This will be a cooperative article borrowing from all. - **Editor**

Harry went for tests at Charlottesville, his red blood count was very low, so they changed his medication. He made it up the stairs to the house when he got home, but after a few hours, fell when he tried to move between two spots. He could not get up himself, and his wife and daughter were unable to assist him to get up, so in accordance with his wishes, they covered him with a blanket and he spent the night on the floor. (Sounds like Harry huh, not wanting anyone to fuss over him.)

Next morning, they called his doctor who told them to call 911 and get him to the emergency room. Once all tests were done, they found he was quite weak due to lack of red blood cells, and also had pneumonia. Since then, the drugs they've been giving him have also affected his blood sugar.

So, the pneumonia is either gone or almost gone. The red blood cell count is coming back. (This is a long-term condition; Harry gets periodic transfusions. If you're able to donate blood, you might want to designate in Harry's name.) Harry is getting stronger, and has good upper body strength. He can get around using a walker.

As some of you know he suffered a compression fracture to a vertebrae some time ago and it has not been a fun recovery. Harry says that it hurts pretty bad, and bad enough he can't stand up straight, but it is not the primary focus right now, and they'll work on it after they get these other things fixed.

Harry thinks they'll let him out the middle to end of this week. If you can visit, I'm sure he'd greatly appreciate that. He's got lots of good stories to tell, and likes to know what others are up to. For any of you who haven't met Harry – he's one of the original "Ole Virginia Hams".

Repeater News

The repeater controller was reprogrammed just prior to Hamfest. A "Hamfest" trailer was inserted for random IDs; the Net Mode was extended to 2130 from 2100 on Thursdays, ten-digit dialing was tested and then fixed, and the rapid dial numbering was tested (if you have rapid dial access, try it and let KW4AW know if it works or not. If it fails, it will be corrected).

During the first full week of June we started experiencing some kind of broadband noise interference on the two-meter repeater. It appears to be associated with the lovely rainfall we have been subjected to lately. That gives us the whole world to track down for source. Bear with us as we monitor, isolate and eradicate this latest aggravation. In the meantime, if things get bad, Control Operators may disable the two-meter transmitter (leaving the receiver enabled for monitoring). If two meters doesn't respond to your transmissions, try 220/440, they should be operational and have Auto-patch access. 100 Hz access is not provided.

ARRL, DEPARTMENT OF HOMELAND SECURITY TO INK STATEMENT OF AFFILIATION

ARRL and the Department of Homeland Security (DHS) http://www.dhs.gov/dhspublic/ will sign a Statement of Affiliation (SoA) at the League's 2003 National Convention later this month in Texas. The convention will be held June 20-22 at the Arlington Convention Center in conjunction with Ham-Com http://www.hamcom.org. Since both ARRL and DHS view community disaster preparedness and response as top priorities, they will pledge mutual support for Citizen Corps--a community-based training and outreach initiative that brings together volunteers and first responders.

"This is all part of the bigger picture of getting emergency communications, aligned with what our government needs," said ARRL President Jim Haynie, W5JBP, who will sign the SoA on the League's behalf. "Amateur Radio stands ready to serve the country as needed in times of emergency."

Chief Operating Officer of the Emergency Preparedness and Response Directorate Ron Castleman will represent the DHS at the signing and serve as the lead speaker during the ARRL Forum, Saturday, June 21, at 10 AM. The forum will take place in an unnumbered room that's to the right of the Ham-Com registration area, not in Room M5 as originally scheduled.

Programs under the Citizen Corps umbrella are aimed at helping communities prevent, prepare for and respond to terrorism, public health issues and disasters.

The Statement of Affiliation will call on ARRL and DHS to collaborate in several areas, including raising public awareness of Amateur Radio as a public safety resource and providing training and accreditation for Amateur Radio emergency communications. The DHS and the League also will work together to promote formation and assist Citizen Corps councils in education, training and volunteer service opportunities that support first responders, disaster relief organizations and community safety efforts.
