FAR – Ruth/KU4WH: There will be a Feb. 2004 Autocall. Autocall will be quarterly now.

<u>WEEEKLY NET</u> – **Ruth/KU4WH**: The weekly nets are going very well. **Mark/KG4JAM**, who has been a regular net controller, has accepted a job in Chicago, IL. Best wishes in your new ventures in and your move to Chicago, Mark. Volunteers for the weekly nets are needed to fill Mark's slots.

<u>ARES</u> – **David/KG4GIY**: We need volunteers to help with the MS Walk on April 17 on the Manassas National Battlefield Park. The MS Society always appreciates our help. A drill at Dulles Airport will occur on May 8. Many types of communications will be used at this event. On May 20, the NCAC Institute will take place, which is official ARES training.

FCC is asking for comments on how to measure BPL signals. That is why we need to read the NPRM.
