AUTOPATCH

Business calls are defined by the FCC as "any communication, the purpose of which is to facilitate the regular business or commercial affairs of any party." Violation of this rule may threaten both your own autopatch privilege, and the use of the patch by the amateur community at large. The access code is for members only, please don't share it.

If the autopatch is being misused, the Control Stations for the repeater, have the authority and capability of disconnecting the call. The Station will then identify itself and explain why you were disconnected. If you have any questions as to why you were disconnected, please call the Control Station that disconnected you for additional explanations. Please do not discuss/argue over this issue over the repeater. Do it by telephone.

If any member should hear someone abusing the autopatch, either for business purposes or not giving their call-sign when initiating the patch, any member should take it upon their own to terminate the patch. Touching any digit except the * and the # will disconnect the patch. Give your call and explain why you did it. Hopefully, we will not have any problems.
