However, the ARRL has announced that this reflection will NOT commence until November 1st of this year. Since the next Manassas exam session is scheduled for the 18th of November, it will include questions from the new Part 97. A new Tune in the World will be effective after November 1st. This will be the 8th edition. Also the ARRL Tech. Lic. Manual - 1st Ed. - will be put into use that same date as will the ARRL Gen. Lic. Manual -1st Ed. An item of interest: the new edition of Tune in the World will be written in an 8th grade reading style.

The FCC Rule Book has been revised and should be ready the latter part of this month. When picking up a new Rule Book, make sure the cover is Red, White & Blue.

On another subject: The Civil War enactment went on nicely. I was overwhelmed by the OVH response. There was one incident where a participant (Union soldier) was overcome by the heat. The OVH had a station at First Aid and another was to have been with the Union Troops, BUT, the Union group ran the Ham away BEFORE the incident and so he could not help.

Back to the Part 97 rewrite: Art (W1CRO) pointed out to me the rewrite permits Extra Class and Advanced Class hams to operate in the Novice segment of 40 Meters, but not the General Class. I have written an inquiry into this and will pass along the result when it gets here. (I suspect an error in the printing, but I am not sure.)

Winter is coming and it usually brings snow. There are two activities which you can participate in if you wish during a Snow Emergency — Annaburg Manor and Prince William Hospital need volunteers to transport nursing personnel. Hams are in an especially good position since they can use the repeater in case of need. However, my own feelings are: your own family comes first, then your own safety. Finally, any help which can be supplied is of value.

GM Issues Transceiver Installation Guidelines:

General Motors Corporation has released a brochure titled Radio Telephone/Mobile Radio Installation Guidelines" for their late model automobiles. GM states that "these guidelines are intended to supplement, but not to be used in place of, detailed instructions for such installations which are the sole responsisbility of the manufacturer of the involved radio telephone or land mobile radio." They indicate that improperly installed transceivers may "adversely affect the vechicle operations such as the performance of the engine and driver information, entertainment and electrical charging systems\*.

The guidelines go over such items as trasmitter location, antenna installation, antenna connection locations, and troubleshooting. ...

Russian Phrases for Amateur Radio:

A 20-page syllabus, "Russian Phrases for Amateur Radio" has been complied by Len (W6HJK) to help amateurs communicate with Russian speaking amateurs. The booklet provides English words and phrases for QSO's, accompanied by the Russian translation and the English translitertion. According to Len, "you need not be an expert in Russian, only interesed in trying."

...There are sections on the Russian alphabet, phonetics, CW characters, numerals, and given names.


This is part of our continuing effort to keep our members well-educated. You may want to become familial with the following metric expressions so as not to sound dated:

- \* Don't hide your light under '35.36 liters.




