AMATEUR RADIO EXAMS

The Ole Virginia Hams Amateur Radio Club will hold an exam session on November 23, 1996. Exams will be conducted for all Amateur Radio license classes. Testing will begin at 9:00 AM in the auditorium of the Northern Virginia Electric Co-op (NOVEC) Building at 10323 Lomond Drive in Manassas. The session fee is \$6.05. ANOTHER ATTACK ON HAM RADIO?

As reported in The ARRL Letter, Vol 15, No 6, NASA/JPL and other space agencies are eyeing the 70-cm Amateur Radio band for a satellite-carried Synthetic Aperture Radar (SAR) system, but ARRL is working to ensure that amateur interests are taken into account as the process moves forward. In addition to the US, The Netherlands and Japan want to use the 430-440 MHz band for SARs to scan tropical rain forests and desert sand. The proposed NASA/JPL radar will reportedly result in a very high-power flux density at the Earth's surface and could interfere with amateur operation, although SAR Transmissions would be brief, not continuous. In other words, SARs will interfere with terrestrial systems whenever they are in view and the equipment is turned on.

WRC-97 likely will be asked to allocate the band 430-440 MHz to the earth-exploration satellite (EES) service and upgrade the status of EES in the bands above 1 GHz, which include amateur secondary allocations at 1240-1300 MHz; 10-10.025 GHz; 24.05-24.25 GHz; and 78-79 GHz.

Current proposals to consider support for SARs at WRC-97 have studied compatibility between space services and other services.

Proponents would also like to scan temperate forests but operators of surveillance radars (such as military systems) have objected that even infrequent interference would be unacceptable. That could rule out SAR operations over North America and Europe, the areas with the greatest number of amateurs and probably those most active in the 70-cm band. Even for those amateurs in the tropical regions, any interference would be infrequent and limited by the need to avoid interference to terrestrial radar.

9. Give factual details of the operations as it concerned Amateur Radio. Be specific, remembering that places, persons, terms, situations very familiar to you may be unknown to the readers.

On Tuesday, October 22, 1996, an all out search and rescue mission was activated in Prince William County near Manassas, Virginia to find a missing child who disappeared from her home the preceding day.

Prince William County ARES was activated to provide communications for transportation and logistics between the event Command Post and the staging area and to provide backup communications, as required, for other search and rescue support groups.

24 hours into the event, it became obvious that manpower would be limited due to activating during a normal work week. Therefore, Virginia ARES District 2 (6 Counties in Northern Virginia) was activated to provide access to more hams. This effort provided all the manpower needed throughout the event.

The event was from 0830 on 22 Oct. until 2130 on 26 Oct. including a standdown period between 1700, 24 Oct until 0600, 26 Oct. for special search and rescue missions using the latest in high technology systems.

Sat. 26 Oct proved to be the most demanding on our resources. For over 12 hours at 5 locations we provided shadows, runners and other services in addition to the communication requirements. During this period, 2 repeaters and 2 simplex channels were used extensively and 2 simplex channels off and on.

10. Comments: Amateur Radio once again proves its ability to provide needed communications services during emergency conditions. In this effort, all support units had their normal assets available and functional. We still

became a vital asset due to the scope of the operation, very hilly terrain from river bottoms to heavily wooded search areas in remote locations.

In approximately 4 hours we went from 'to my knowledge, amateur radio is not officially requested but I can use you for my operation' to "essential personnel".

As in all operations, we had our problems, including power loss on a repeater, however, we were able to overcome these without any loss of service.

We learned that police, fire, rescue and other services are plagued with news services being able to monitor their frequencies. The only improvment I can come up with is make a plea to the amateur radio community to add portable packet capability to their arsenal of resources for emergency support.

My deepest respect and heart felt THANKS goes out to all participated in the many, many aspects of this operation.

FCC Phonebook

The FCC Phonebook contains a complete listing of FCC employee telephone numbers. With some exceptions, the e-mail address for FCC employees is the first initial and first seven letters of the last name, followed by: @fcc.gov. There is also a functional listing which gives telephone numbers for FCC subject areas, and an Organizational listing. The phonebook is updated weekly. The location of the zipped file is http://www.fcc.gov/phone.html

If you are looking for the phone number of a specific person at the FCC, you can search the FCC phonebook online.

You can also download the complete FCC phonebook. To do so, first download the zipped Phonebook file, pbver30.zip, and unzip it. The unzipped files include an alphabetic listing, fccpb.asc, a functional listing, funcpb.asc, and a executable file, fccphone.exe. You can view the phonebook most conveniently by launching fccphone.exe as an application under Windows. Fccphone.exe only works in Windows. If you do not have Windows, you can simply load the unzipped *.asc files into your word processer and search the listings in fccpb.asc and funcpb.asc, using your word processor's word search function. 
