OVHARC REPEATER NEWS Part 1

Just to give everyone an update on repeater happenings. All three repeaters are on line at this time (07 August 1999). We have linked the 220 MHz and 440 MHz repeaters for testing and will unlink them in the near future. Most of the time we will be running each repeater separately. Thursdays and Sundays, we'll

link them all together for the nets.

The two meter repeater has CTCSS tone access capability which is activated when needed. The access tone is 100.0 Hertz. The two other repeaters will be equipped with CTCSS tone access and all repeaters will have CTCSS tone transmit capability installed before the year is out (unless the trustee gets a job before then).

We do NOT have a Digital Voice recorder (DVR) or "voice mailbox" attached to the new controller. A DVR is on the "wish-list". So far, you can use emergency autopatch, rapid-dial autopatch and plain old autopatch. Time of Day (A10), time and temperature (*80) and DTMF tone pad test (*5 plus keys to test) are also available to all members.

We have received the crystal modules for the new GE MASTR II 440 Repeater and can now proceed with repair and tune up for that unit. When finished, it will replace the little Kenwood repeater we are using now. Expect to see a little more range when that happens, since we'll be doubling our power output.

Say "Thanks" to Butch - W4HJL and Mike - WV3H for their help over the last few months. It was critical to keeping things on air in several instances. Also a big "Thanks" to Steve - N4OGR for his contributions in providing some much needed cooling and air handling at the site.

We still have a few gremlins lurking about and we will be tracking them down and stomping on them as time goes on.

OVHARC REPEATER NEWS Part 2

The repeaters have been relatively trouble-free over the last month.

The 442.200 Repeater went off-line for a day in August - gremlins struck again. A number of voltage measurements were taken before disturbing the equipment or resetting it. Then, when nothing could be identified as a cause, the equipment was "power cycled" and it returned to normal operation (sound familiar? Like re-booting Windoze). We will continue to chase this down.

An interfering signal vaguely reminiscent of the 152.240/158.100 pager intermodulation problem of 1996 - 1997 reappeared on 146.370 on Friday, 27 August 1999. Naturally, that's the input frequency for our 2-meter repeater. We activated the 100 Hz tone access to minimize the aggravation. If you can't access 146.370/146.970 MHz, check to see if you have PL activated on your rig. Also, if you are in the vicinity of the old Manassas Bakery on Route 28 and the interference is present, see if you can copy the signal on 146.370 and drop a line to Art, KW4AW (kw4aw@n4wjn.#nova.va./usa.noam or kw4aw@ieee.org) with your findings or comments.

The 223.060/224.660 MHz Repeater seems to be behaving itself.

Both the RLC-3 Controller and the telephone modem have been placed on an uninterruptible power supply as temporary measure to coast through minor power outages. A set of regulator circuits is being built to connect them to the main battery back-up unit at the site. As soon as we finish this little task we plan to:

- (1) Expedite development and installation of circuitry for the tone-receive and tone-transmit capability in each repeater.
- (2) Complete refurbishment and checkout of the **GE MASTR II UHF** Repeater to be installed for 447.200/442.200 MHz.

Our **NOVEC** hosts are reviewing the site wiring and acting to ensure we have access to the emergency generator near the **Repeater snack**. This is to enable our full participation and support in **emergency** activities within Prince William County and Northern Virginia.

We have not experienced any new (unidentified) interference nor have we been identified as an interference source, even though a substantial cellular radiotelephone installation has been completed recently just below our antennas. Within reason, good installations CAN co-exist. Thank goodness, it wasn't a pager installation though.
