Minutes of the Ole' Virginia Hams Amateur Radio Club Meeting – August 15, 2005

Ruth/KU4WH called meeting to order at 2000 Eastern Time.

Following the **Pledge of Allegiance**, all present stated their names and call signs. There were **22 OVH members** and one guest present.

BUSINESS MEETING

The minutes of the July 2005 meeting were approved.

COMMITTEE REPORTS

BPL – **George/K4GVT** - George met with officials of the City of Manassas on Tuesday, August 10 along with N3OH, K4GVT, W4HJL, W1CRO, and W4KRL. George noted that we need to file complaint letters with the FCC when we hear the BPL interference.

TREASURER'S REPORT - **Bill/N3OH** – Bill read the Treasurer's Report.

REPEATERS – **Butch/W4JHL** – We are still waiting to get the antennas replaced, but the repeaters are working well.

HAMFEST – **Keith/KM4AA** – We had a meeting of the Hamfest committee. We're looking into things to change next year. We need to review our security and traffic control situation. For now we'll have it at the fairgrounds and the same day, but that could change in the future. Keith covered several issues regarding Hamfest.

JOTA – **Paul/N2PJ** - Paul wants to pull together a list of who has done what in the past to help coordinate the next JOTA, which occurs on October 15, 2005. Paul will be able to spend more time on JOTA this year.

ARES – **David/KG4GIY** - David thanked all who helped put up antennas on the Red Cross chapter house. Many folks have been trained in **NIMS (National Incident Management System)**. David asked that we forward that information to him if you have passed the exam. NIMS is a requirement to work in an **EOC**. This is a county-level directive. The next training for ARES is on Sept 17. A drill will occur on October 19. Sept 10 is the "911 celebration" (meaning the 911 emergency system, nothing specific to the events of 9/11/2001). October 22 is the next Institute.

Howard Cunningham / WD5DBC gave a presentation on the **Marine Corps Marathon**. He needs **150 ham volunteers**. This year there will be about **28,000 runners**, more than twice the number as last year. The course has been changed a bit. We especially need some packet operators, but Howard needs hams who can do anything. www.NCACDC.com is the website to sign up. Information will also be on the ARES website. You need to sign up by October 1 to get credentials.

CLUB EC – **David/KI4AZX** – The **Try-It-Now Triathlon** is on September 21, and we will need volunteers for that.

FIELD DAY – **Brian/WC4J** - All went well. The total number of contacts was down but total points were up because of the bonus activities.

SUNSHINE UPDATE – **Steve/N4OGR** – **Steve Meade's/KB4OF** wife (**Brenda/WD4RKH**) had gall bladder surgery. If anyone has some more information, please pass it along. **Doc's/W1IMX's** son had surgery as the result of injuries to his wrist, but should make a full recovery. Two former OVH members passed away recently.

FAR – **Ruth/KU4WH** - **Autocall** will no longer exist as the situation currently stands. **David/KG4GIY** noted that new people are needed to do the work required to keep Autocall up and running. If by **Sept 15** a new team can be pulled together, it will continue, but otherwise the winter issue will be the last. It takes one person about **50 hours of work** per month to sustain Autocall. Regardless, the **Hamfest** will be **Sept. 10** and **11** and volunteers are needed.

NEW BUSINESS

David/KG4GIY noted that the **OVH annual dues (\$10)** are lower than those of most other AR clubs, and asked if we might considering **raising the dues**, and also asked what was necessary to do so. **Bill/N3OH** noted that the Club bylaws state that dues can be changed by a recommendation of the finance committee and a majority vote of a quorum at a meeting.

50/50 RAFFLE - **\$32** was collected and **Dwight/AI4II** won. Dwight donated his winning back to the Club. Thank you Dwight.

The meeting adjourned at 2127 Eastern time.

Hurricane Watch Net Revises Activation Plans for Fickle Ophelia



(Sep 12, 2005) -- As Ophelia continues its erratic behavior off the Eastern Seaboard, the Hurricane Watch Net (HWN) is poised to activate on 14.325 MHz Tuesday, September 13, at 1900 UTC. WX4NHC at the National Hurricane Center (NHC) will activate at the same hour. The HWN cancelled plans to activate over the weekend after then-Hurricane Ophelia, now once again a tropical storm but nearly a Category 1 hurricane, failed to make landfall. According to the NHC, as of 2100 UTC, Ophelia was some 260 miles south-southwest of Cape Hatteras, North Carolina, moving slowly northwestward packing maximum sustained winds of nearly 70 MPH. The NHC says Ophelia "has the potential" to regain hurricane strength during the next 24 hours.

FCC Proposes to Drop Morse Code Requirement for All License Classes



(Jul 20, 2005) -- The FCC has proposed dropping the 5 WPM Morse code element as a requirement to obtain an Amateur Radio license of any class. The Commission recommended the change to its Part 97 Amateur Service rules in a *Notice of Proposed Rule Making (NPRM)* in WT Docket 05-235. Any rule changes proposed in the *NPRM* would *not* become final until the FCC gathers additional public comments, formally adopts any changes to its rules and concludes the proceeding by issuing a *Report and Order (R&O)* spelling out the changes and specifying an effective date. That's not likely to happen for several months. The FCC declined in its *NPRM* to go forward with any other suggested changes to Amateur Service licensing rules or operating privileges beyond

elimination of the Morse requirement.

ARRL Board Adopts Modified Regulation by Bandwidth Proposal



(Jul 19, 2005) -- Following considerable discussion and debate, the ARRL Board of Directors has approved a modified set of recommendations to regulate the use of amateur spectrum by emission bandwidth rather than by emission mode. Last April, the ARRL Executive Committee reached consensus on a set of regulation-by-bandwidth proposals to serve as the basis of an FCC *Petition for Rule Making*. Following additional fine tuning based on hundreds of comments from the amateur community, the Board formally adopted a further-modified plan at its July 15-16 meeting. The revised plan includes a stipulation that the League "will promptly undertake a procedure to establish a band plan to be utilized with the proposed subband allocation petition, and, until such time as that band plan is in place, the existing band plan will be in force." ARRL

CEO David Sumner, K1ZZ, remarked after Board's 12-3 vote that improved band planning is critical to the success of the League's regulation-by-bandwidth proposals and will require the support of the amateur community at large.

American Red Cross Asks New Prospective Volunteers to Stand By



(Sep 12, 2005) -- ARRL Alabama Section Manager Greg Sarratt, W4OZK, says the response to the American Red Cross's urgent call over the weekend for Amateur Radio volunteers was so successful that he's asking additional volunteers to stand by until the agency renews its call for more Amateur Radio operators. Sarratt said he and his team at the American Red Cross volunteer marshaling center in Montgomery, Alabama, are processing the volunteers who responded from the urgent call this past weekend and matching up available volunteers with needs. Sarratt says the Red Cross so far has processed upward of 100 Amateur Radio volunteers for its Gulf Coast disaster relief effort. He anticipates the agency will need additional volunteers in the near future, but suggests that anyone interested in signing up wait for another announcement. Amateur Radio is a major means of emergency communications for a number of critical disaster relief efforts, Sarratt said.

Amateur Radio Industry, Individuals Step Up to the Plate for Katrina Relief



(Sep 9, 2005) -- Some two dozen members of the Amateur Radio industry and individual radio amateurs have contributed equipment for use in the Hurricane Katrina relief effort. The disaster wiped out the Amateur Radio infrastructure in many US Gulf Coast communities. The donations were made as gifts to ARRL, which is redirecting these resources as needed to the disaster zone. Some donors have offered valuable services and supplies.

Amateur Radio Volunteers Filling Many Communication Gaps in Gulf Region



(Sep 8, 2005) -- Amateur Radio operators from states along the Gulf Coast and elsewhere in the US continue to volunteer their skills and expertise as the Hurricane Katrina relief effort heads into its third week. ARRL Section Managers (SMs) and Section Emergency Coordinators (SECs) across and around the affected region have been teleconferencing daily to keep their efforts on the same page. In the field, Amateur Radio Emergency Service (ARES) and other volunteers are assisting as needed to support communication for relief agencies as well as for state and local government and even the Federal Emergency Management Agency (FEMA). Louisiana SEC Gary Stratton, K5GLS, reports that earlier this week Amateur Radio was the only means for state officials at the state emergency operations center (EOC) in Baton Rouge to communicate with the so-called "Florida parishes" above Lake Pontchartrain.

NCVEC Question Pool Committee announces new schedule



(Sep 12, 2005) -- The National Conference of Volunteer Examiner Coordinators (NCVEC) has announced that the Question Pool Committee (QPC) has adjusted its schedule for revising Amateur Radio examination question pools. This decision was prompted by recent FCC announcements, changes in radio communication technology and recommendations from VECs. "The QPC feels it is imperative to produce a new Technician Class pool now to better position the Amateur Radio Service for growth in the years ahead," the QPC said in a statement released September 9. "The new schedule impacts previously announced release dates for all three question pools." The Technician class (Element 2) pool now tops the schedule and is due for release in January 1, 2006, effective July 1, 2006. General class (Element 3) pool updates, previously scheduled to become effective on July 1, 2008, will be released December 1, 2006, and become effective July 1, 2007. The Extra class (Element 4) pool originally scheduled for 2005, will be released on December 1, 2007, and will become effective July 1, 2008. Barring any major rules changes, subsequent updates to all pools will follow the traditional four-year cycle, the QPC said. Selected by representatives of the 12 VECs attending the NCVEC's annual conference. The QPC consists of Chair Jim

Wiley, KL7CC, Anchorage VEC; Perry Green, WY1O, ARRL VEC, and Larry Pollock, NB5X, W5YI VEC. A team of associates representing various VEC organizations as well as experts selected from the amateur community will assist the QPC. Interested persons are encouraged to submit questions to the NCVEC QPC via the NCVEC Web site.

Radio Amateurs of Canada to reply to BPL consultation paper



(Aug 5, 2005) -- Industry Canada (IC) has begun a public consultation process for the introduction of BPL in Canada. The proceeding, spelled out in [Canada Gazette Notice SMSE-005-05](#), dated July 19, will determine how BPL will be introduced in Canada. It will include the development of a new certification standard for medium voltage powerline carrier systems. "The intent of this consultation paper is to seek comment on the deployment and regulation of BPL systems, including the specific equipment standards and operational requirements which address potential interference to radio services," IC explains. A consultation paper is roughly the equivalent of an FCC *Notice of Proposed Rulemaking*. Interested parties have 120 days to reply. Radio Amateurs of Canada ([RAC](#)) plans to reply to this consultation directly to IC and through the Radio Advisory Board of Canada ([RABC](#)), an association of Canadian radio spectrum user associations to which RAC belongs. RAC Vice President of Regulatory Affairs Jim Dean, VE3IQ, a member of the RABC Executive, will chair a working group preparing RABC's response. Joe Parkinson, VE3JG, will serve as the working group's RAC delegate. "RAC is not against BPL," the organization said in a statement. "It is against the interference to radio services created by BPL, and looks forward to this consultation process as an opportunity to have an input into the certification standard." The RAC says it will "aggressively push to ensure the concerns of the Amateur Service are addressed in the RABC response." Canadian amateurs are invite to address all comments on questions in the consultation to Joe Parkinson, VE3JG, RAC, 720 Belfast Rd, Suite 217, Ottawa ON K1G 0Z5, ATTN: BPL Team, or via e-mail to ve3iq@rac.ca or jqparkinson@rogers.com. The working group expects to wrap up its work in early November. RAC will update the process in the "Latest News" section of its Web site.

Tennessee hams to launch balloon carrying 802.11b access point, APRS



(Aug 4, 2005) -- Terry Trapp, KE4PJW, and a group of friends hope to launch a balloon Saturday, August 6, that will provide--among other things--a 802.11b wireless access point (WAP) operating on channel 5 (2432 MHz) under Amateur Radio Part 97 rules. The balloon will go aloft from Springhill, Tennessee. Also onboard will be a digital camera and an APRS tracker. Trapp says that since this is the group's first flight, he's not sure how high it will go but estimated it could reach 75,000 feet. "We hope to launch at 10 AM," he told ARRL. "We would like as many amateurs as possible to attempt to connect to the balloon." The WAP will be open access (WEP disabled), and Trapp says it should provide host configuration via DHCP. "We will be using [NetMeeting](#) at the launch site," he said. "Simply connect to the host 'netmeeting.ham,' and if we have a good connection, we will be able to videoconference." Trapp invites those without *NetMeeting* capability to visit [here](#). "The site should have a place for you to fill out your call sign and leave a short message," he explained. An IRC server may be set up [here](#). The WAP is a stock [Linksys](#) model BEFW11S4 with diversity enabled. The balloon will have a patch antenna aimed at the ground, while one of the router's stock dipoles will be in the vertical position. "We will be using a 75-cm dish antenna and a wireless bridge at the launch site," Trapp added. The APRS encoder and transmitter is a [Byonics Pocket Tracker](#). It produces about 150 mW of power and will be using an inverted groundplane antenna, Trapp said. It should beacon with an SSID of AA4VU-11. The camera is a small Polaroid digital, modified to take "very small" images every three minutes. Others involved in the project include K4IDC, KG4QQK, KI4AMX, KD4NMD, KQ4TV and KG4OZL. Hams Become "First Responders" as Conventioneers Forced to Evacuate



(Aug 3, 2005) -- Radio amateurs attending the ARRL Rocky Mountain Division Convention July 30 in Bryce Canyon, Utah, were among the first to respond when release of a noxious substance felled more than 50 people. Utah ARRL Section Manager Mel Parkes, AC7CP, and other hams swung into action to assist after conventioneers and other guests near an inside pool adjacent to the convention area at Ruby's Inn lodge began complaining of nausea, headaches and difficulty breathing sometime around 11 AM. Parkes later suffered the effects of the substance--now believed to be pepper spray--and was among those treated at the scene before being taken to a hospital.

PCSat2 installed on ISS during space walk



(Aug 3, 2005) -- The [PCSat2](#) Amateur Radio package has been installed on the exterior of the International Space Station (ISS) as Materials International Space Station Experiment 5 (MISSE5). Astronaut Soichi Noguchi, KD5TVP ([NASA TV photo](#)), unfolded the suitcase-like Passive Experiment Container (PEC) holding PCSat2 and other experiments mounted atop the ISS P6 truss structure at around 1110 UTC August 3 during a space walk with Astronaut Steve Robison. Noguchi deployed the "tape measure" antennas by pulling up a couple of Mylar strips that allowed the antennas to

pop out. Built by US Naval Academy students under the guidance of APRS guru Bob Bruninga, WB4APR, PCSat2 will operate in cooperation with the Amateur Radio on the International Space Station ([ARISS](#)) program. It will provide a 10-meter PSK31 multi-user transponder, an FM voice repeater for possible use with ISS crew members and an AX.25 packet system for use as a UI digipeater and for telemetry, command, control. Bruninga says PCSat2 may be ready for use within a few days, but he asks that stations not attempt to use the system until it's been checked out and an announcement made. In the meantime, Bruninga has invited well-equipped ground stations to help capture early telemetry on the alternate downlink of 437.975 MHz during PCSat2's first few days of activation. Telemetry will be at 1200 and 9600 baud. E-mail telemetry files to pc2@grc.nasa.gov. Bruninga also has asked 1200 baud IGates or SATgates to monitor 437.975 MHz and feed the global APRS system [live telemetry](#) page. PCSat2's primary downlink frequency is 435.275 MHz; the packet digipeater up and downlink frequency is 145.825 MHz. [More information](#) is on the USNA Web site (**Note: the USNA servers have been down for at least the past 24 hours**). Bruninga says the UHF downlink is only 1 W and will require a beam to hear it.

Amateurs to get "new" FM satellite



(Aug 3, 2005) -- PO-28 ([POSAT-1](#))--Portugal's first satellite, launched 12 years ago--will be turned over to Amateur Radio use in the very near future. That was the word this past weekend from [AMSAT-UK](#) Secretary Jim Heck, G3WGM, during the AMSAT-UK International Space Colloquium in Guildford, England. Launched September 25, 1993, the satellite operated as a packet store-and-forward BBS (9600 baud FM FSK) on Amateur Radio frequencies for several weeks in early 1994. Over the years, PO-28's primary usage has been commercial, although plans have called for eventually shifting its operation to ham radio use. G3WGM reports that following lengthy negotiations it

has been agreed that the satellite can be switched permanently to amateur frequencies. The changeover is expected to take a couple of weeks. The Portuguese satellite was built at the University of Surrey as part of a collaborative satellite technology program that involved industry and academe. Uplink frequencies will be 145.925 and 145.975 MHz. Downlink frequencies will be 435.075 and 435.275 MHz.

Australian BPL-related submissions express concerns



(Aug 3, 2005) -- The Australian Communications and Media Authority (ACMA) says the majority of the 275 submissions to its [BPL Discussion Paper](#) show a high level of concern regarding BPL interference and its management. The lion's share of the submissions--222 in all--came from radio amateurs. Others were from telecommunications companies, broadcasters and government agencies. One commenter, telecoms provider Optus, recommended a "cautious approach" and expressed concern over potential BPL interference to its cable services as well as over the issue of regulatory and competition certainty. Broadband cable and DSL provider Telstra worried about interference to its broadband and HF radio services saying its calculations indicate "ubiquitous BPL could have serious consequences for cable modem networks" and could lead to "significant degradation of VDSL in cases where power and telecommunications lines are in close proximity." Commenting through their industry association--the Personal Emergency Response Services Association (PERSA), medical alarm providers concluded that electromagnetic interference from BPL to PERSA is potentially severe, continuous and widespread. "BPL interference could prevent a call for assistance in a life-threatening situation, resulting in death or injury," PERSA asserted. Not surprisingly, submissions from the BPL industry recommend less-onerous management techniques, although power company Bytecan did acknowledge interference to various services and devices during its tests. Others commenting included CB radio, model aircraft enthusiasts, outback radio users and equipment suppliers.--*Phil Wait, VK2DKN/Wireless Institute of Australia*

Potter says Zellers is eager to become fully engaged in his new post, supporting and coordinating the various national intruder watch programs in IARU Region 2 and working together with the IARUMS Coordinators in Regions 1 and 3.

Hundreds File Comments on FCC Morse Proposal



(Aug 2, 2005) -- Hundreds already have filed comments via the FCC's Electronic Comment Filing System ([ECFS](#)) on the Commission's recent proposal to eliminate the Morse code requirement for all license classes. A formal 60-day comment period starts once the FCC's *Notice of Proposed Rule Making and Order* ([NPRM&O](#)) in WT Docket 05-235 appears in the *Federal Register*, but all comments filed now are valid nonetheless. Issued in response to 18 petitions for rule making--including one from the ARRL--the FCC's *NPRM&O*, released July 19, dealt only with the Morse requirement and turned away all other proposed rule changes. A random sampling of the more than 360 comments filed at this point suggests the tide is running firmly in favor of the FCC's stance. Some even praised the Commission.
