## Minutes of the Ole' Virginia Hams Amateur Radio Club Meeting – September 18, 2006

John / KG4NXT called meeting to order at 2000 Eastern Time.

Following the **Pledge of Allegiance**, all present stated their names and call signs. There were **26 OVH members** and **five guests** present.

## **PROGRAM**

Kerry Osterhout of the Prince William County Police Department's Crime Prevention Unit gave us a presentation on Fleet Watch. Kerry had just returned to the United States after having been overseas for six and one-half years. She is in charge of the County's Fleetwatch and Business Watch programs, and well as the Worship Watch program. Kerry noted that a lot of what the PW County Police do depends on the general public. Our role is to observe. We know our communities best. So, when something doesn't look right, we know. She wants us to report criminal / suspicious activity. Steve / N4OGR will be our contact person for Fleet Watch. Kerry brought Fleet Watch bumper stickers and would like for each of us to be a call-in station. The bumper stickers would help identify us as call-in stations.

For emergencies, dial 911. Dial (703) 792-6500 for non-emergencies. Kerry gave us a list of possible suspicious situations, and the handout describes those situations. The handout also described the information that is needed when we call in. Identify yourself as a Fleet Watch member and a member of OVH, and stay on the phone until the operator tells you to hang up and/or call back. If you use the radio, give a callback number. It's actually better to use the cell phone because the operator can get the call-back number through caller id. It would help if we keep a record of the calls that we make.

Thank you Kerry for taking the time to give your presentation on the Prince William County Fleet Watch program to the Ole' Virginia Hams.

#### **BUSINESS MEETING**

**John / KG4NXT** read a thank-you letter from **Mend-a-House**. We donated the money from the **OVH Hamfest bake sale** plus additional funds to Mend-a-House for a total of \$400. For 22 years, Mend-a-House has helped build ramps, lifts, and other devices in homes to make those homes more accessible to people with disabilities. They have a fund raising event on October 11.

John / KG4NXT thanked all who helped out with the OVH Special Event commemorating the anniversary of the 2<sup>nd</sup> Battle of Manassas / Bull Run. The event went very well, and all of the QSL cards have been mailed out. We also received several QSL cards from Hams who contacted OVH during the event.

**John / KG4NXT** noted that **Bill / N3OH** had an unexpected business commitment and could not be at the meeting, and thus could not update the Treasurer's Report. However, John and **Mary Lu / KB4EFP** noted that the Club's financial situation had not changed significantly since the August 2006 business meeting. We should have an updated Treasurer's report at the October 2006 business meeting.

Steve / N4OGR noted that we received a certificate of appreciation from the folks at National Night Out for our recent participation in their event.

<u>MEMBERSHIP</u>: Joe / KI4OHR – One new potential member was read in by Joe: Matthew Babcock / KI4RDB, who will be voted on for membership at the October 2006 OVH meeting. Edward Morthimer / WA3TOL and Patricia "Trisha" Rabe / KI4PCM were voted into OVH membership by unanimous votes. Welcome to the Ole' Virginia Hams, Edward and Trisha.

<u>EDUCATION</u>: Trisha / KI4PCM – The new Technician class starts this Thursday. Several OVH members have volunteered to help with the class. The class will take place at the **Red Cross building** in **Old Town Manassas**.

<u>REPEATERS</u>: Art / W1CRO – All repeaters are currently working well. However, the back-up 440 machine has some problems. Efforts are being made to fix that machine.

<u>JOTA</u>: John / KG4NXT - We need some more volunteers to help with the event. We don't yet have confirmation on having the event at the **Urbana Swim Club**, but we are working on that. The event takes place on October 21. **Theresa / KG4TVM** has printed up a flier. We also need people to help with setup the day before.

<u>BPL</u>: George / K4GVT – We recently had Ed Hare/W1RFI from ARRL visit Manassas. He found some more "BPL hot spots." But things are relatively and suspiciously quiet at the present time with regard to BPL noise. We have asked the FCC to come to Manassas to verify the situation. George spoke with Riley Hollingsworth today (October 18, 2006), and George understands that FCC is coming to Manassas to investigate the BPL situation.

<u>ARES</u>: David / KG4GIY - David suggested that we prepare our "action plan" and be prepared in the event of an emergency. David also noted that there are several activities coming up: The MS Challenge Walk on September 29 to October 1; Simulated Emergency Test (SET) on Oct 7; Diabetes Association event at the Freedom Center on October 14; NCAC Institute on October 21; Operation Fowl Play on October 23 to 25

(this is state-wide event that simulates distributing pharmaceuticals); the **Marine Corps Marathon** on October 29. In December, there will be an event for PW County which will be a full-scale demo for Emergency Managers, in which the plan is to demonstrate HF and video communications. If we know a ham on the Pacific Coast or perhaps Alaska, that person could help with a demonstration of long-distance communications. The minutes of the August 2006 OVH meeting were approved.

George / K4GVT won the 50/50 raffle. \$28 was collected, and George donated his winning share of \$14 back to the Club. Thank you George.

**Joe / KI4OHR** reminded all that a net takes place from **Virginia Railway Express** train # 327. The net starts shortly after the train leaves Alexandria, which is just after 4:00p.m. The net takes place on the simplex frequency of 146.550.

# Attention All Amateurs...



BPL Orders Exceed FCC's Jurisdiction and Authority, League Court Filing Says (Oct 12, 2006) -- The ARRL this week notified the US District Court of Appeals -- DC Circuit that it's appealing certain aspects of the FCC's Part 15 rules governing broadband over power line (BPL) systems. The ARRL Executive Committee ratified plans to go forward with the *Petition for Review* when it met October 7. The League is asking the court to review the FCC's October 2004 *Report and Order* (*R&O*) establishing Part 15 rules to govern BPL systems as well as its August 1006 *Memorandum Opinion and Order* (*MO&O*) that dealt with various petitions for reconsideration of the 2004 *R&O*, including one from the ARRL.



FCC Releases Long-Awaited "Omnibus" Amateur Radio Report and Order (Oct 12, 2006 [REVISED Oct 12, 2006 13:14 ET]) -- Ending a protracted waiting period, the FCC's Report and Order (R&O) in the so-called "omnibus" Amateur Radio proceeding, WT Docket 04-140, was adopted October 4 and released October 10. In it, the FCC adopted nearly all of the changes it had

put forth in its 2004 *Notice of Proposed Rulemaking (NPRM)* in the proceeding. The *R&O* the FCC released this week does *not* include action on the Commission's proposal to eliminate the Morse code requirement for all license classes. *A Report and Order* in that proceeding, WT Docket 05-235, is pending. ARRL President Joel Harrison, W5ZN, expressed the League's gratitude to the FCC for acting this week in the wide-ranging proceeding.



Scouts Worldwide to Participate in Jamboree On The Air 206 (Oct 10, 2006) -- Jamboree On The Air (JOTA) -- a nearly 50-year-old tradition -- provides an opportunity to showcase Amateur Radio for Boy and Girl Scouts and Guides, Cub Scouts and Brownies around the world, some of whom will be part of the next generation of radio amateurs. JOTA takes place this year over the October 21-22 weekend. JOTA founder Les Mitchell, G3BHK, said in 2000 that he never imagined when he drew up the plans and rules for the first JOTA in 1958 that its popularity would increase and spread around the world.



**DXCC Desk approves operation for DXCC credit** (Oct 10, 2006) -- The ARRL DXCC Desk has approved this operation for DXCC credit: 9Q1D (Democratic Republic of the Congo), current operation beginning September 22, 2006. IARU Monitoring System seeks over-the-horizon radar reports (Oct 5, 2006) -- IARU Region 2 Monitoring System Coordinator Bill Zellers, WA4FKI, says Amateur Radio stations on the West Coast and as far east as

Arizona have reported hearing over-the-horizon <u>radar signals</u> on the low bands. VE7BZ in British Columbia recorded the radar's signal October 1, 1353 UTC, on 3.795 MHz. The radar, apparently located on Hainan Island, Peoples Republic of China, has shown up on 160, 80 and 40 meters and sometimes is quite strong. "We're talking about signals 40 over 9!" Zellers told ARRL, adding that the radar is obliterating 160 meters in the Far East. On 80/75 meters it appears as high as 3.8 MHz, while on 40 meters, it's showing up on the lower 25 kHz or so. Typically there are about 50 seconds between signal pulses. He said the radar signals are strongest on a heading of between 285 and 320 degrees from California or Arizona. Zellers requests reports from stations hearing the over-the-horizon radar signals as well as any other signals that do not appear to belong on the Amateur Radio bands. He suggests the following format when reporting: Your call sign, time in UTC, frequency, emission type, signal strength, propagation and signal bandwidth in kHz. **160-Meter Experiment Will Explore Marconi's 1901 Transatlantic Success** (Oct 5, 2006) -- A 160-meter beacon will take to the air this fall and winter from Cornwall, England, to explore how Guglielmo Marconi was able to span the Atlantic by wireless for the first time on December 12, 1901. Radio history says that's when the radio pioneer at a receiving station in Newfoundland successfully copied the Morse code letter "s" sent repeatedly by his team in the Cornwall town of Poldhu. The latter-day venture is a cooperative effort of the Poldhu Amateur Radio Club (PARK) in Cornwall and the Marconi Radio Club of Newfoundland (MCRN). The Poldhu club's Keith Matthew, GOWYS, said the 2001 centenary of Marconi's achievement reopened discussion into the mechanism by which the 1901 spark transmitter signal propagated. **Space station crew to take brief Soyuz trip** (Oct 4, 2006) -- The all-ham crew of the International Space Station will take a brief ride around the space outpost October 10. Expedition 14 Commander Mike Lopez-Alegria, KE5GTK, Flight Engineer Mikhail Tyurin, RZ3FT, and European Space Agency astronaut Thomas Reiter, DF4TR, will shut down vital station systems and undock their *Soyuz* spacecraft from its port at the aft end of the *Zvezda* Service Module. "They will then take a 30-minute trip that will relocate the *Soyuz* to the Earth-facing docking port on the station's *Zarya* module," NASA said this week. "The maneuver will free *Zvezda*'s docking port for the arrival

of a new Russian Progress cargo spacecraft later this month. Lopez-Alegria and Tyurin are still settling in for their six-month stay in space." Reiter has been aboard the ISS since the summer. No Amateur Radio on the International Space Station (ARISS) school contacts are on the schedule until later this month.

Martin P. Miller, NN2C, SK (Oct 4, 2006) -- Martin P. "Marty" Miller, NN2C, of Melville, New York, died September 30. He was 84. Miller was a DXCC Honor Roll member on both phone and CW. An ARRL member, he was very active in the Long Island DX Association (LIDXA), where he was a member for more than 25 years and president for 7 years. "He would regularly bring his new DXpedition videos down to LIDXA meetings and was always trying out new software and hardware in his station," said LIDXA Secretary Ed Whitman, K2MFY. "He loved the hobby with a fervor." Miller was among the US troops that went ashore at Normandy in 1944 ahead of the first invasion wave as part of a special combat assault unit. He received the Silver Star for his actions that day. Licensed more than 30 years ago (he formerly held WB2VEX), Miller also served as president of the QCWA's Long Island Chapter

81 and belonged to the Grumman Amateur Radio Club. Miller was a regular at Dayton Hamvention and at the IOTA [Islands on the Air] conference in England. "November November Two Charlie will surely be missed by his stateside and DX buddies," Whitman said.
